The North Bucks Road Club recommends wearing an approved hardshell helmet when racing and on club runs. We also recommend that members have third party insurance through membership of the CTC or British Cycling. It is also highly recommended that riders in Time Trials fit a bright rear light for safety.

The Rules and Regulations of the club are available on the Club Website (northbucksroadclub.org.uk) and all members are encouraged to read them.

The club organises a number of events during the year on the road (Time Trials and Road Racing) and on closed roads (The Bowl, MK). Club members also participate in open events and in cyclo-cross events organised by the Central Region. Social rides are also organised weekly and you may consider taking part in an Audax event or going touring. Website – The Club website holds the following personal data:

1. Contact e-mail addresses for Club Committee members, required for prospective and current club members to contact the club – these are not listed as plain text on the web page;
2. We post results of our Time Trial series on our website. These results contain the following information on race participants: Name, Club, Category, Placing, Time. We also include results on veteran standard and on our own handicapping system. Race participants also include members of other clubs and those unattached to clubs;
3. During the season we compile League Tables in a number of categories, which are derived from the results described in paragraph 2 above.

We occasionally post results of cycling events organised by other clubs on the website. Usually these link to the organisation under who's rules the event was run (e.g. British Cycling, LVRC, CTT).

We do not hold member details on our website, and no members have accounts on the website except the website manager. We do not handle membership or take payments via the NBRC website, this is handled via the British Cycling website using their secure software.

We do not hold contact details of members (other than the e-mail addresses of Committee members), and do not circulate e-mails from the website.

Cookies – The club website does not set cookies on other computers.

Logs – The website back-end logs failed attempts to log in to the administrative area of the website.
